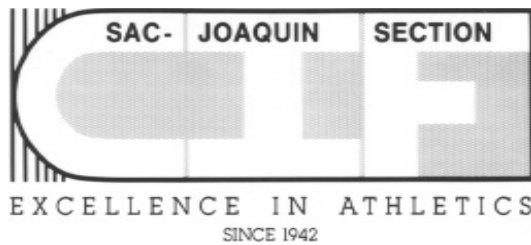

**Approximate times listed** – Each succeeding round will begin at the conclusion of the previous round. Coaches and wrestlers should remain in close proximity to the arena in order to be ready for each match.

### **League Results**

The league tournament directors are responsible for faxing or e-mailing (westsidedesign@att.net) the results of their league tournament to John Baldwin no later than Monday, February 14, 12:00 p.m. **First and last name, grade, and school of wrestlers must be included on the results form or they will not be accepted.** If any known changes occur after the deadline, please contact John Baldwin ASAP at (209) 586-9924. **\*Any student information that is omitted will not be accepted.**

### **Entry Fees**

The entry fee for the 2011 Division V Tournament is \$15.00 per wrestler. **Each school is responsible for paying the fee of each qualifying wrestler.** If a wrestler is unable to compete, it is the responsibility of the coach to make arrangements for the alternate and collect the \$15.00 entry fee. **ALL ENTRY FEES MUST BE PAID PRIOR TO FRIDAY'S WEIGH-INS.**

### **Registration and Weigh-ins**

Coaches must pick up and pay for their packets before their wrestlers can weigh-in. Coaches can check in at 8:00 a.m. in the gym. Scales will be made available to check weights beginning at 8:00 a.m. A pass will be in your packet for each qualified wrestler representing your team. Wrestlers will weigh in, by weight, at 9:00 a.m. on both days. Wrestlers will wait on the gym floor with the other wrestlers in their weight until their weight is called. **ALL PARTICIPANTS MUST BE INSIDE THE GYM AT 9:00 A.M. SHARP OR THEY WILL BE DISQUALIFIED FROM THE TOURNAMENT.**

### **Competition Weigh-in Form**

Each coach is required to bring his/her team's Competition Weigh-in Form to the Sac-Joaquin Section Divisional competition. Tournament officials will retain all forms.  
PENALTY: Failure to comply will result in the entire team being ineligible to compete and charged with forfeiture.

### **Alternates**

Alternates become eligible to wrestle if a qualifier from their league is unable to participate in the tournament. An alternate shall move into the bracketing as the lowest qualifier from the represented league. In the event that a league does not have an alternate present, the next league in alphabetical order will receive the alternate (i.e. TVL 125 lb. wrestler is unable to participate, the TVL 125 lb. alternate is not present, the alternate slot would go to the GEL, then the MLL, and then to the SL). If there is a spot in a bracket left vacant, it will be regarded as a forfeit and scored accordingly throughout the tournament.

### **Weight Classes**

The following weight classes will be in effect for the Sac-Joaquin Section Divisional Championships. Note: The 2-pound growth allowance will be used in accordance with the National Federation Wrestling Rules. (Rule 4-4-4).

### Coaches Passes and Meals

Three coaches' wristbands will be issued to the head coach of each school. Only those coaches with wristbands will be permitted at mat side. Only coaching will be permitted mat side (no stats or filming). All rules pertaining to the conduct of coaches, participants and spectators will be enforced. Wristbands will be required to enter the hospitality room for Friday's and Saturday's coaches' lunch. NO EXTRA WRISTBANDS WILL BE PROVIDED.

### Concessions

The snack bar will be open at 8:00 a.m. both days and will have a variety of breakfast, lunch and snacks available.

### Warm up Area

There will be a warm up area available. When wrestlers are sent to a mat, they will be expected to be ready to wrestle!

### Security

We ask that all wrestlers AND COACHES STAY AWAY FROM THE MAT AREA UNLESS THEY HAVE BEEN ASSIGNED TO A MAT TO WRESTLE. Only two representatives from each school will be permitted mat side during a match. THIS RULE WILL BE STRICTLY ENFORCED. Any violation of this will result in a deduction of team points. We will also enforce NO mat-side video recording by parents or coaches. All video recording must be done from the bleachers.

THE SUMMERVILLE HIGH SCHOOL CAMPUS IS OFF LIMITS TO ALL WRESTLERS AND SPECTATORS. ANY WRESTLER FOUND ROAMING THE CAMPUS WILL BE SUBJECT TO DISQUALIFICATION FROM THE TOURNAMENT.

### Awards

Medals will be awarded to 1st-4th place. There will be a formal awards ceremony after the Finals. **ALL PLACE WINNERS MUST BE IN WARM UPS (LETTERMAN JACKETS ARE ACCEPTABLE) TO RECEIVE THEIR AWARDS. NO HATS PLEASE!**

### Masters Meet Qualifiers

The top four place winners in each weight class (no alternates) will qualify to the Sac-Joaquin Section Masters Tournament held at Stockton Arena on February 25 and February 26, 2011.

**(Note: Please read the weigh-in procedures listed below very carefully and make sure that your wrestlers understand the procedures and timelines.)**

**WEIGH-IN AREAS AND PROCEDURE:**

The weigh-in area and check scales will be open at 8:00 a.m.

The weigh-in area will be inside the gym.

All wrestlers must be in the weigh-in area by 9:00 a.m.

Each weight class will have an assigned area on the floor in the gym.

Weigh-ins will be done by weight class.

Coaches are not allowed in the weigh-in area.

The only individuals allowed in the weigh-in are the wrestlers and the tournament staff.

The Weigh Master will conduct the weigh-in and check conformance to appearance as required by the National Federation 2010-11 Wrestling Rules Book.

The announcer will begin to make calls at 8:45 for all wrestlers to go to the weigh-in area.

He will make calls every 5 minutes and make a final call at 8:59.

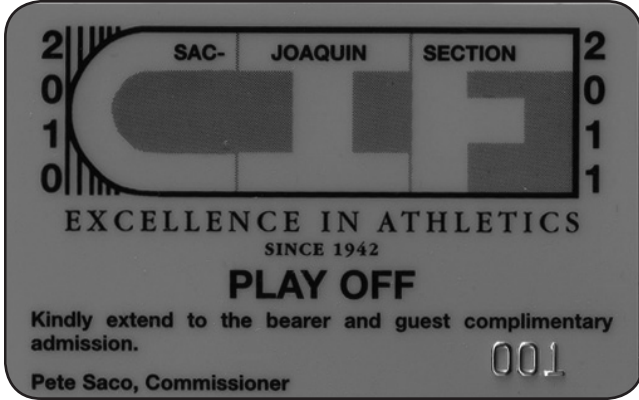
If multiple scales are available, a contestant may step on and off the first scale two times to allow for mechanical inconsistencies in that scale. If the contestant fails to make weight on the first scale, the contestant shall immediately step on each available scale one time in an attempt to make weight. During time off the scale (s), activities that promote dehydration are prohibited. (NFHS Rule 4-5-3)

The weigh-ins will begin at 9:00 a.m. sharp and continue until the last weight class has weighed in.

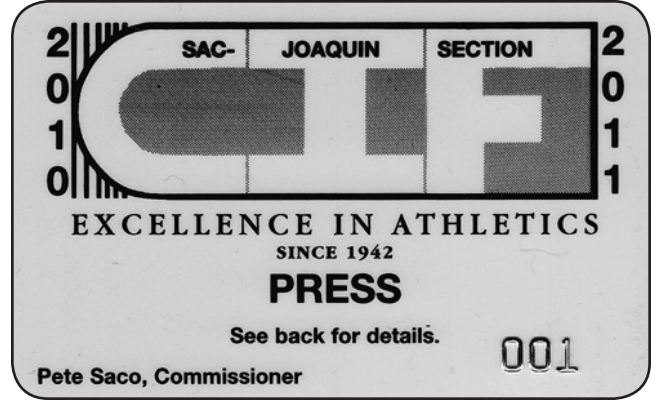


**CIF SAC-JOAQUIN SECTION PLAYOFFS

2010-11**

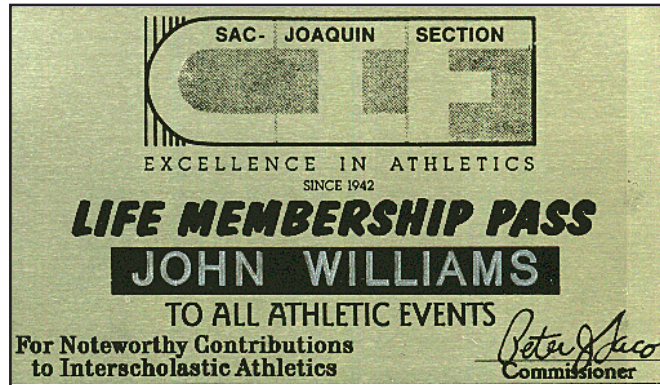
**PLAYOFF PASS  
(ORANGE)**



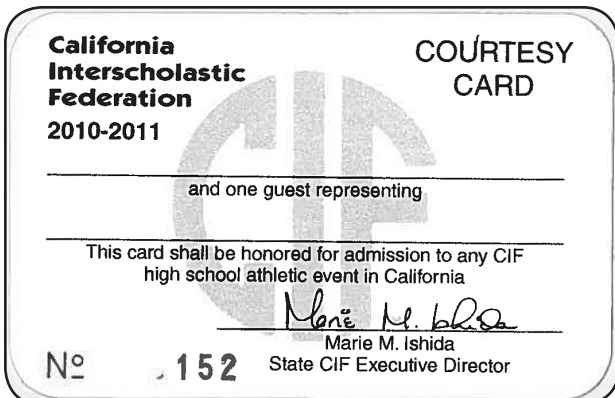
**PRESS PASS
